Co-operation with developing countries forms an integral part of the foreign policy of every developed country. Problem-free reporting of development assistance projects and transparency are essential for strategic management, co-operation planning, efficient allocation of resources and ultimately for a development assistance budget to grow.

DART fully satisfies the demand for simple and effective reporting of development assistance in line with OECD rules as well as transparent reporting of projects and financial flows. The solution was created and fine-tuned in co-operation with the Ministry of Foreign and European Affairs SR and the Ministry of Finance SR. Compliance, both with OECD requirements and a high level of sophistication, was confirmed by representatives of the OECD Development Co-operation Directorate.

#### ACCURATE REPORTING IN LINE WITH OECD CRS++

The main aim of DART is to ensure the simple, problem-free submission of information on development assistance projects and the generation of DAC (Development Assistance Committee) tables in line with the rules and directives of the OECD. Accuracy of reporting is ensured by the application logic. This guarantees that the data structure and the form of reports correspond to the methodical requirements of the OECD (CRS++).

#### TRANSPARENCY AND ACCESS TO INFORMATION

An additional aim of the solution is to ensure the transparency of projects and financial flows. The web portal [slovakdev.sk](http://slovakdev.sk) satisfies the requirements of IATI (International Aid Transparency Initiative) standards for publishing data on development co-operation. The solution makes all information easily accessible, comprehensible and applicable.

#### ALL DATA UNDER ONE ROOF

The transparent provision of project information and quality reporting requires precise and complex data. DART is a central database that collects and records all projects for every type of assistance provided and from all donors. The system is available in a user-friendly interface.
